- ◆ Available for Seniors age 60+
- ◆ Provide door-THROUGH-door transportation
- ◆ Serving Madison County residents
- ◆ \$25 yearly membership fee includes first 3 trips
- ◆ \$2 per round trip
- ◆ \$1 each additional stop requested
- ◆ Providing assistance for seniors who are able to walk on their own or with assistance of a walker or cane
- ◆ Customized rides to best meet the needs of the seniors
- ◆ Volunteer drivers use their own personal vehicle for transportation
- ◆ Volunteers are thoroughly screened and a background check is performed
- ◆ Volunteers must have a clean driving record
- ◆ Trips are pre-paid through a secure website
- ◆ Scholarships are available



WE DO NOT WISH TO TAKE THE PLACE OF ALREADY EXISTING TRANSPORTATION MODELS IN AND AROUND WEST TENNESSEE. WE WANT TO BE ANOTHER OPTION FOR THOSE SENIORS WHO ARE LOOKING FOR A MORE PERSONALIZED RIDE TO KEEP THEM ACTIVE AND ENHANCE THEIR DAILY LIVES.

HOW WILL SCHOLARSHIPS WORK?

WE WANT TO PROVIDE THE OPTION FOR BUSINESSES AND INDIVIDUALS TO “GIFT” RIDES TO CLIENTS, FAMILY, FRIENDS, PATIENTS, CHURCH MEMBERS, COMMUNITY MEMBERS, ETC.

SCHOLARSHIPS ARE AVAILABLE IN SEVERAL DIFFERENT OPTIONS:

1. **DONATE A SPECIFIC AMOUNT OF MONEY TO BE USED BY ANYONE**
2. **DONATE A SPECIFIC NUMBER OF RIDES TO BE USED BY ANYONE**
3. **DONATE TO A SPECIFIC PERSON OF YOUR CHOOSING**
4. **DONATE AND DESIGNATE YOUR DONATION TO BE USED SPECIFICALLY FOR YOUR PARTICULAR ORGANIZATION.**

EXAMPLES OF HOW YOUR DONATION WILL BE USED:
